## **1** Apologies for absence

Apologies for absence had been received from Councillor Mr A. Leggatt and Mr P. Langridge. Cllr Mr A. Zerny had submitted apologies for their anticipated lateness.

Councillors were reminded that they should declare an interest in any matter of personal or prejudicial interest to be discussed at this meeting. Information about this requirement had been on the table.

#### **3 Minutes**

The minutes of the previous meetings held on 15<sup>th</sup> September 2015, which had been previously circulated, were approved and signed as a true and accurate record.

# **4 Matters Arising**

17 Oak Tree Branch resolved (ii) to contact Mr Day about how to proceed with the Deadwood feature. The response from Mr Day 28/9/15 was noted "Certainly need to discuss how to proceed. I have been considering to locate it somewhere near the entrance to HS playing field maybe as part of a revamped bed in the car park."

4 To receive crime statistics from Bedfordshire Police – it was noted that a letter has been sent to Olly Martins, Bedfordshire Police and Crime Commissioner about the rather low crime clear up statistics which has been logged by the Police and Crime Commissioner office, under ref: 2015/000500 and forwarded to the Commissioner for his attention. The Town Clerk advised that an acknowledgement had been received. 15 Neighbourhood Plan. It was noted that Cllr Zerny has been advised by Central Bedfordshire Council that 16 parishes are currently developing Neighbourhood Plans: Caddington and Slip End, Toddington, Barton le clay, Wrestlingworth and Cockayne Hatley, Stondon, Clophill, Marston Moretaine, Hockliffe, Kensworth, Fairfield, Henlow, Arlesey, Studham, Northill and Totternhoe. Cllr Zerny was also advised there is no *(CBC)* funding for this *(Neighbourhood Plan)*, but Planning have a contract with BRCC *(Bedfordshire Rural Communities Charity)* to provide support. It was also noted that Cllrs Hobbs, Lean and Whitfield have been informed.

#### 14 External Auditor – Audit for the year end 31 March 2015

The Town Council noted the correspondence received from the Town Councils External Auditor.

A copy of the annual return which had been returned by the External Auditor was presented to the town council in the council papers.

The Town Council then worked through the issues arising from the audit.

It was **resolved** (i) to approve and accept the Annual Return which was presented to the town council for year ended 31st March 2015, following its return by the External Auditor now that they had given an audit opinion. (ii) that the Town Council note that minor error with regard to comparative figures for the year end 31<sup>st</sup> March 2015 were restated as the council have changed their basis of accounting and the external auditor has reviewed the adjustments made and they are satisfied they are correct. (iii) that the Internal Auditor's recommendations are implemented as had previously been resolved on the 16<sup>th</sup> June 2015 minute "11 Finance iv To receive a report from the internal audit for the year 2014/15 it was resolved to approve the final internal audit report including implanting all recommendations for the financial year 2014/15."

# **15 Correspondence**

It was **resolved** to approve of the Community Right to Bid application for the George and Dragon Public House.

# 16 Speedwatch

Members discussed about permanent signage to advise that speedwatch takes place. Cllr Zerny was asked if he would contact CBC Highways about speedwatch signage. Members didn't want to see additional any additional posts and that signs to be installed on existing posts.

It was **resolved** that (i) Cllr Zerny contact CBC Highways about speedwatch signage. (ii) Cllr Ellison provide Cllr Zerny with the relevant information about speedwatch.

# **17** Cemetery and Churchyard

Cllrs Gibb advised that Cllr Langridge had a proposed detailed maintenance plan for the St Mary's Churchyard, which split the area into three zones.

Cllr Gibb then advised that they are planning to consult with various stakeholders about the churchyard and to include an article about the churchyard in the next newsletter.

Cllr Gibb advised that his and Cllr Langridge's proposal is to retain and improve the churchyard, reducing costs and increase wildlife and wildflowers.

Cllrs Gibb finally advised that a meeting was arrange for representatives of the St Mary's Church and the Town Council to meet on the 13<sup>th</sup> October 2015.

#### 18 Hall Hire

Members discussed at length about free use of town council buildings. It was suggested that removal of two existing free users and these were e. Other CBC meetings Clock House and Community Centre and f. Citizens Advice Bureau uses the Community Centre on a Tuesday if they have any appointments.

It was **resolved** to refer the free use of town council buildings to the Buildings and Facilities Committee.

# **19 Potton Consolidated Charity**

A member of the public left the meeting.

Cllr Leggatt advised he has a copy of the constitution for Potton Consolidated Charity and the above is incorrect and it should be "......the Council needs to nominate the four people to serve as Trustees ...........".

Members noted that the four outgoing town council trustees for the Charity are all willing to be nominated. The Chairman asked if anyone would like to be nominated.

It was **resolved** that the four town council nominated trustees of the charity are as follows: Cllr Alan Leggatt Cllr Angus Macdonald Jean Way Anna Adnitt
