

# Chairman's Report NOV 2011

Following the independent inspectorate's decision that there were no grounds to refuse Central Beds. LDF plan for two developments to the east of Biggleswade Road and to the east of Sutton Mill Road, these developments are now likely to go ahead. Consequently it will be in the best interests of the town now to get the best possible deal from the Section 106 planning gains which will be forthcoming from the developers. The Town Council will be participating in a series of stakeholder meetings comprising CBC, the developers, landowners and any other interested parties in order to identify what will be best for Potton. Recommendations from the Town Plan survey will be one of the main inputs.

This year is the twenty fifth anniversary of our twinning with Langenlonsheim in Germany. To mark this occasion, the Town Council was invited to send representatives to Langenlonsheim to sign a reaffirmation of the twinning charter. This was duly done on 29th October in front of a large audience in the community hall at a celebration concert involving the Gemischte Chor, Langenlonsheim and St. Mary's Singers, Potton. Members of Potton Twinning Association Committee were also represented. I had a long discussion with the Ortsbürgermeister, Hr. Michael Cyfka, regarding how we might revitalise twinning and we have both undertaken to strengthen our links in the future. He is young and very enthusiastic and I have great hopes that he will drive things forward in Langenlonsheim and we must do the same here.

Anyone can benefit from an exchange with our twin town - youth organisations, sports clubs, service organisations (e.g. fire service), singing groups, businesses, friends and families etc. etc., in fact any common interest group. If you are interested please contact the Town Council or Twinning Association for more information. I would like to congratulate both choirs for their outstanding performances during the celebrations under the expert eye of their musical directors – Stefan Göth and Douglas Coombes.



Finally, Christmas is nearly upon us again and that means we start putting up the lights in the town square. Working parties will be out every Sunday throughout November with the exception of Remembrance Sunday. Volunteers are always welcomed and we start at 10.00 am.

More locally, I am please to report that I have carried out my election pledge to give everyone in the ward the chance to have their say on the major issues affecting the area by issuing a survey, the results of which are now coming in.

As far as Potton is concerned, the major issues are the future of the library, the proposed large scale housing developments and the traffic, in particular the number of lorries and other traffic coming through the town, and speeding cars. Also, if you didn't put your name on the form but would like feedback on specific issues raised, do let me know.

Other issues I have taken to Central Beds include local buses, roads, education and the Music Service. I have also fought the extra allowances approved for the former leader and deputy leader of Central Beds council, which amount to  $\pounds 10,721$  per year.

I will be aiming to continue to keep people up to date with everything that is going on, and to hold councillor's surgeries in Potton and all the surrounding villages.

## POTTON TOWN PLAN

Work continues on implementing your input to the Town Plan. We have recently held a Seasonal Market and Apple Day and are currently working on plans to partly clear the banks of the Brook to encourage the Water Voles.

A team is keen to encourage the installation of more nesting boxes for Swifts in the centre of Potton. These need to be installed before next years nesting in May. A representative from the RSPB will be at the March Seasonal Market to help.

Discussions have commenced between our Town Council, Central Beds Council and the Developers for the Housing Estate East of the Biggleswade Road to look at the proposals and to ensure that the Town receives the expected benefits. We will keep you informed of our progress.

Proposals under discussion at the present time include improvements to the Henry Smith playground, an Adult outside Gym, a Community Orchard / Wildflower Meadow (with picnic area) and trying to find a way to hire a Youth Worker.

We are always looking for volunteers to help with projects to improve your community.

Do not forget that the Xmas lights will be switched on at 7pm on Friday 2nd December with the next Seasonal Market on Saturday 3rd December from 9am until 1pm.

# More officers to tackle Crime in Our Communities

Bedfordshire Police have drawn up ambitious plans to improve the service provided by the Force while also saving taxpayers' money.

From October 2011, the Force and the Police Authority will deliver a more streamlined process to improve both operational capacity and capability. This means that more officers will be available to deal with incidents reported to us by the public.

The Force carried out a detailed review of the way it organised key departments to identify areas where costs could be cut and performance improved. During the process, residents confirmed they were happy for structural matters to be dealt with by the Force so long as they received an appropriate police response when needed and crime continued to fall.

The new changes will see the number of police officers dedicated to local policing double from 92 to 185. This means a larger number of officers will be available to tackle local crime, anti-social behaviour and other community concerns while PCSOs will carry out more patrols.

There will no longer be any geographic boundaries or divisions separating communities. Instead, a Chief Superintendent will oversee Local Policing while another will be responsible for Tackling Crime.

Through reorganisation, the Force and the Police Authority will speed up response times. A new centralised team will respond to incidents county-wide officers will get to where they are needed more quickly as well as save money.

Meanwhile, a greater number of incidents will be resolved over the telephone to reduce demand on frontline staff thanks to a new appointment system for non-emergency issues. A recent survey found that people accepted this as a good way of dealing with non-urgent matters. A new three digit nonemergency number will be introduced in the autumn, after which time all you will need to dial is 101 for non-urgent situations.

Peter Conniff, Chair of Bedfordshire Police Authority, said: "We've listened to our residents throughout the review process and their comments have very much informed our strategic decisions. The changes have been made to promote greater access to police services and deliver a more effective response that meets the expectations of our communities."

# Don't miss out: funding opportunity for excellent projects in the Greensand Ridge area

There is around £1 million still available to award eligible businesses and community groups in Potton and the wider Greensand Ridge area.

The Greensand Ridge Local Action Group (LAG) is made up of people with a keen interest in the area. The LAG is awarding funding to projects which meet local objectives: **smallscale tourism, local food and drink, eco-business and resource efficiency, multi-use spaces and small rural business.** 

Anyone interested should have a clear business plan and should have already tried to find money from other sources to cover costs. Successful projects can receive, on average, between 40 to 50% funding.

To date, 7 projects have been successful at securing a grant including Gamlingay Eco-Hub, community venue, The Old Piggery, B&B near Haynes, The Green Café in Clophill and the Working Woodlands Centre in Maulden.
