- 2. Proposed 50mph and 30mph Speed Limits B1042 Sandy to Potton.

Members discussed the proposal and Cllr Ellison advised that a Traffic Management Officer from the Police had given a verbal

recommendation to Potton Speedwatch about the introduction of 40mph buffer zone on the Gamlingay Road entrance into Potton.

It was **resolved** to write and request that in addition to the proposal a 40mph buffer zone is introduced from just before Deepdale to the 30mph zone in Potton.

15 Potton Hall for All

The Town Clerk advised members that Cllr Emery had advised that unfortunately he has nothing to report on the behalf of the Hall for All for this meeting.

16 Grant applications

Members noted that the Town Council has received three grant applications.

Members also noted that the council had budgeted £500 for Section 137 in 2015-16 and that they approved £100 from the budget for the Fire Charity at the last meeting and various other grant applications are likely to arrive during the financial year.

Members discussed the three grant applications.

3. Potton Bowls Club.

It was **resolved** to write to Potton Bowls Club to advise them to contact Potton Consolidated Charity (PCC) about gaining funding for new chairs and then contact the Town Council if they are unsuccessful with an application to PCC.

Parking on the verge at the entrance to Ridgeway opposite the BP garage on the furthest side from the Royal Oak was brought to attention of members by Cllr Zerny.

Cllr Zerny advised that the verge closer to the Royal Oak has wooden bollards to prevent parking on the verge.

Cllr Zerny asked if the verge is town council land and the Town Clerk advised that the land is Highway land (Central Bedfordshire Council).

Members discussed about if the triangle footpath area at the entrance to Biggleswade Road is removed as per the recent Biggleswade Road planning application, the Town Council could consider moving the planter to the verge.

It was **resolved** that parking on the verge at the entrance to Ridgeway opposite the BP garage on the furthest side from the Royal Oak is an agenda item at the next town council meeting.
