#### Potton - Partnership Community Defibrillator

Potton Town Council has arranged for a Partnership Community Defibrillator to be installed on the outside of the Library in Potton, following permission from Central Bedfordshire Council.

Funding to purchase the Defibrillator unit is a scheme funded jointly from Bedfordshire Fire and Rescue Service and Central Bedfordshire Together.

Potton Town Council has agreed to fund the following with regard to the unit, installation of the unit, community awareness training, support service costs from The Community Heartbeat Trust for servicing the Defibrillator unit.

The defibrillator unit comprises of Cardiac Science defibrillator, secure locking cabinet, signage, a ready kit (pack containing scissors, small towel, razors and a one way breathing mask).

The defibrillators will be key-locked for security, with access given by Ambulance Service Control only on receipt of a 999 call. Ambulance crews will also be despatched to the scene.

Bedfordshire's Chief Fire Officer Paul Fuller said: "In the same way that you don't need to be a fire fighter to use a fire extinguisher, you don't need to be a paramedic to use a defibrillator. The important thing is that they help to save lives."

Installation of the Defibrillator unit on the outside of Potton Library was the town council's preferred location as this is a central location and it is a requirement that the unit is accessible 24 hours a day, 7 days a week, 365 days a year.









Community Awareness Training will be delivered by Community Heartbeat on Monday 23rd March at 7pm in the Community Centre, Brook End.

# THE CHAIRMAN'S MESSAGE - COUNCILLOR PETER J. LANGRIDGE

Spring is sprung, the grass is ris, I wonder where the birdies is? Yes the dark cold wet days are behind us again and it's time to look forward to the bright early warm mornings when so much more can be achieved in the day.

The best Christmas light display in the area has been put away again for another year thanks to all those willing volunteers.

Some things have settled and been sorted, but some others are still in the air, subjects like the possible expansion of the existing traveller site in Potton. It is good that our Central Bedfordshire representation keep us informed of the current thinking on this subject within Central Beds so we can be prepared.

Which brings me to the subject of the forthcoming elections in May. There will be elections for our two Central Beds representatives, but we may also have elections for Potton Town Council if there are sufficient candidates. Potton Town Council has for some time now relied on co-option to maintain the numbers. Some people have expressed an interest in standing but have never come forward to be nominated. I strongly urge anyone who would like to serve on the town council to put their names forward. In these difficult financial times an election will cost the town money but it would be well spent if it means democracy in action and the people of the town make their own choice on who represents them.

Speaking of money and Central Bedfordshire Council, leads to the council tax precept. As predicted Central Beds has again this year withheld grants to the town council that Central Government says should be disbursed to town and parish councils within its area. Potton Town Council have had to have a larger percentage increase to try and maintain the current level of service.

We try to be a forward looking council with ideas to improve our town and community. We all know these cost money but no-one wants to stand still at best, or fall back on things for the town. At times this may only be an extra  $\pounds I$  per household per month but it can make all the difference.

It would appear that we have some mindless morons in our midst who can ruin some things for others. A short time ago the seat on the children's zip wire in the park was vandalised by someone's dog. At our expense we replaced the seat and now a few weeks later it has happened again. Those people allow their animals to ruin facilities for everyone. I would urge everyone to be vigilant when in the HSPF or Mill Lane park and I would urge everyone to report any anti social behaviour they witness to the police. Remember it is your money they are wasting when we have to repeatedly clean up after these people.

We are already grateful to the Potton Consolidated Charity who have been very generous to the town when it is possible. Such things as play equipment in both parks. #### **POTTON TOWN COUNCIL BUDGET 2015-16**

This has been a particularly difficult year for budget setting with Central Bedfordshire Council again choosing to not pass Council Tax support funding to its town and parish councils despite government guidance that it should do so. The loss to the Town Council from Central Bedfordshire Council witholding the funding is nearly £15,000.

As advised in the Winter 2014/15 Newsletter unfortunately Potton Town Council will now have to increase its proportion of the Council Tax to maintain services.

The Town Council on 7 January 2015 decided to increase the charge for a band D property by £1 a month. The charge for a band D property will now be £90.05 a year.

This is still less than £1.75 per week per band D household for all the functions, projects and services that the Town Council provides.

## Vandalism to Aerial Runway

In December, due to recent deliberate and repeated acts of vandalism, the seat for the Aerial Runway at Henry Smith Playing Fields was removed, in the interests of public safety. This is the second time that the aerial runway seat has had to be removed. Side is a picture of the aerial runway seat that had to be removed in December 2014 and a new seat.



The damage seems to have been caused by dogs biting and pulling on the seat of the aeriel runway. Replacing the seat on the aerial runway costs Potton Town Council (You in the form of Council tax) in the region of £250 each time. We would ask that residents are vigilant and to report any acts of vandalism that they see to the Police on the non-emergency 101 number.

Alternatively, if you wish to remain anonymous you can contact Crimestoppers on **0800 555 III** (free from a fixed line, mobile charges may vary).

The aerial runway seat was replaced in December 2014 and we were hoping that it would be used as intended, for the enjoyment of children in the area. Unfortunately the Aeriel Runway seat in Henry Smith play area looks like it has been chewed by dogs again, less than six weeks from when the seat was replaced.

Side is a picture of the seat removed in January 2015. The damaged seat has been removed as it could have caused a serious injury to a child using the piece of play equipment as intended. At this stage a replacement seat has not been ordered.

## Central Bedfordshire Councillor's Report - Cllr Doreen Gurney

Broadband I am supporting Central Bedfordshire councils funding for additional rural broadband. There is also public funding secured for a minimum of 2.25M£. I am able to report we will have a purse of private funding, without this addition there would be no possibility of the outlying villages in the Potton ward, having their broadband upgraded. Some of these outlaying villagers are on an at risk list, the private funding now puts them in a positive position.

Housing My feedback from the older population is they prefer to remain independent, in their own home for as long as possible. I feel that Parish and Town councils should take up, social housing schemes where possible. In Everton where I live, this has allowed younger families, and older residence the option of staying in their preferred surroundings.

#### CENTRAL BEDFORDSHIRE COUNCILLOR'S REPORT - CLLR ADAM ZERNY

Roads Potton should benefit from a large chunk of Highways funding in the near future.

Central Beds Council has committed to introduce a 20mph zone across the centre of the town in the coming months. Initially this will just be 20mph signs but I'm seeking further funding during the next year for what they like to refer to as 'compliance measures' i.e. anything that encourages motorists to stick to the limits. I am disappointed the council have elected not to include Sandy Road, Bury Hill, Hatley (past the church) and other outlying areas, but will be seeking extensions to the zone once it's in place.

There will also be funding for 'real time bus time displays' in Market Square to show when the next bus is due. However, this has been heavily delayed due to technology issues and the council is still trying to confirm they can make the displays 'talk' to the buses themselves as they are on two separate systems!

The council has also agreed to extend the no-parking lines on the junction of Biggleswade Road and Blackbird Street from where they currently end, opposite the Royal Oak, all the way up to the BP garage. The work is likely to take place in the spring. I have urged them to be wary of further issues with parking and road speeds that may be unwanted side effects.

Broadband I've discovered that only one company - BT - will bid for a £7.5m council contract to supply superfast broadband across our area, a project which shows a number of areas will potentially be excluded from the upgrade.

In December 2013, Central Beds announced its superfast broadband plan, with Cockayne Hatley, Tempsford and parts of Eyeworth, as well as many other areas of Central Bedfordshire, shown as not getting superfast broadband.

However, there have even been big problems with some of the areas that were supposed to be getting super fast broadband, such as Dunton (where delays are occurring after disagreements between BT and Central Beds, over whether it's viable).

Plenty of negative comments were made about the level of coverage provided, so in an attempt "to rollout superfast broadband coverage further" the council held what it called an 'Open Market Review' to see what broadband providers thought commercially viable. They received a number of complaints from the public over the areas left out, and also received feedback from a broadband provider. Central Beds Council refuse to let me see the feedback from the provider:

The council received extra government grants towards areas not thought commercially viable, so the eventual sum of money available for superfast broadband is £7.5m (to cover Central Beds, Luton, Bedford and Milton Keynes). To tender for a provider, the council has opted to go via the BDUK procurement framework but It has come to light that Fujitsu have stated they intend not to bid for projects, so BT are likely to be the only company who will tender.

Despite concerns raised, Central Beds insist "the council and BDUK will be undertaking extensive value for money analysis of any tenders received to ensure best value is achieved".

The tender was due to end at the beginning of February but the council has already intimated it may extend the deadline.

#### **COUNCIL ELECTIONS**

In May 2015 a local election of all fifteen places on Potton Town Council will take place. Potton Town Councillors will come to the end of their 4 year term and so will either re-stand or step down. So there is an opportunity to become a Councillor and contribute to your community. Should there be more than 15 residents wishing to stand as a Councillor, then an election will be held. If fifteen or less people come forward, they will automatically be 'elected' with no voting taking place.

So if you want to vote for the members who will represent you for the next four years, we need to have more than fifteen nominated candidates.

Initially, you may have little knowledge of Council work but this will come, along with experience and confidence. As a new Councillor you will bring to the Council fresh enthusiasm, new ideas, a care for your community and a willingness to learn.

A candidate for the Town Council is qualified if at the time of nomination they are: -

- I. A British subject or Irish citizen
- 2. 18 years of age
- 3. Either on the list of electors for the town or during the last twelve months you:
- Occupied land or property in Potton as owner or tenant
- Had your principle place of work here
- · Lived in, or within three miles of Potton.

Town Councillors are unpaid and give their time for free to the community on a voluntary basis. Their job is to represent the interests of whole community.

### Hall Hire - Availability at the Community Centre and Mill Lane Pavilion

There is a large hall at the Community Centre in Brook End with a kitchen. There is also a carpeted upstairs hall 5 meters square with kitchen facilities. The upper hall is suited to smaller meetings and group events. There are a number of vacant sessions during the day time and at weekends at the Community Centre, give Mrs Williamson a call during office opening hours to see if either of the halls would be suitable for your group or function. The centre is near to Potton Market Square for the bus route and shopping and a free car park is very nearby.

The Pavilion at Mill Lane has a large 9 metre square hall and kitchen, there are facilities for people with disabilities and a baby changing unit. The floor may not be suitable for dance groups. We have a large free to use car park. If you are planning your child's Birthday party, the Pavilion at Mill Lane may well be the ideal location.

Calling all pensioners! Are you claiming all the benefits you are entitled to? Every year around £5.5 billion of benefits goes unclaimed by older people. In particular, many older people aren't claiming Pension Credit, Housing Benefit and Council Tax Benefit. This could add up to thousands of pounds of unclaimed benefits individuals are missing out on every year. #### **Potton Hall for All**

There has been a desire for a new large community Hall in Potton for a number of decades which was reflected in the Potton Town Plan 2009-19. We now have the best opportunity to achieve this having been allocated the land (together with all the services) on the new development east of the Biggleswade Road. This development, which currently has outline planning permission, consists of around 150 residential houses, the Community Hall, a light industrial area and some community greenspace along the brook.

The new Hall for All steering committee has been working hard with the local community to bring this forward during the past two years. With your help, they have raised money to fund a Feasibility Study and instruct an architect to produce an initial design based firmly on feedback and consultations with local people and community groups.

They are now trying to raise funds to cover the design and other costs to get the project to full planning permission. The residential site developers will, through section 106 monies agreed with Central Bedfordshire Council, contribute towards the Hall build costs in stages as the houses are sold. However, other monies will be required to complete the project which will be raised through a combination of individual donations, grants and foundations etc. Once built, this larger community facility will host arts, sports and community activities as well as wedding receptions, conferences and family celebrations.
