

### Chairman's message

### Hall for All



Another success last year was the Hall for All build generally, which did unfortunately run in to an issue caused as a result of the site's

power supply not being where it was supposed to be according to the plans, and a delay due to bad weather and the need to reschedule contractors as a result. This has been resolved and as of 2nd January the building has a power supply, so the work can be rescheduled and as things move forward, we hope it'll be complete and ready for occupation by the end of March. ### Local Plan

Something I feel I must bring to your attention is the review of the Central Bedfordshire Council (CBC) Local Plan, as this potentially DOES affect everyone directly. The plan defines the areas that are considered by CBC as acceptable for development, for industry and housing, and calls for sites to be nominated for consideration. So. if you have views on this please do keep your eyes open for any consultation on the sites and respond. I'm sure our Ward Councillors Adam Zerny and Tracey Wye will promote/publicise these and be able to answer any questions you may have.



As a council we have a neighbourhood plan which will be impacted by any outcomes of this process and the council's neighbourhood plan group will be looking at any proposals. Here with the views of the new ministers we have to be realistic and understand that it is likely that some development may come our way. This being the case, we as town need to ensure that any substantive development is built in the most acceptable place, with Section 106 developer contributions being to Potton's direct benefit rather than somewhere else in the county that will not benefit Potton directly.

#### Budget

Lastly, as we all know the price of everything has gone up, and this is the case for the council as well particularly the costs related to employment as a result of the budgetary changes made by the Government. Last year we had to increase Council Tax by 10%, but we do not intend to repeat this. This year to be able to maintain the services we provide to you we have calculated that there will have to be an increase to Council Tax by 7.5%, which in monetary terms is nominal compared to the rise that CBC are likely to be levying to make their budget work. ### Your local environment

### **Managing Potton's Trees**

There are many trees throughout the town, but just over 300 of them are the responsibility of the town council. These are located on land which the town council has responsibility for maintaining, namely Henry Smith Playing Fields, St Mary's Churchyard, Sandy Road Cemetery, and Mill Lane Recreation Ground.



Most trees bordering public highways and public footpaths are the responsibility of the highways or rights of way teams at Central Bedfordshire Council (CBC). The remaining trees are on private property and their management is the responsibility of the householder or landowner.

There are approximately 670 trees throughout the town (on both public and private land) which are subject to a Tree Preservation Order (TPO), protecting them from unsolicited removal or damage. Remedial work or removal due to disease requires application to and permission from the local planning authority, not the town council.

Generally speaking, the town council only carry out active management of the trees they are responsible for if the tree is diseased, dangerous or damaged. Every three years, an arboriculturist report is produced on behalf of the town council for their trees. The report assesses the health of each tree, any safety risks posed to the public, and advises a programme of



remedial actions required to maintain the tree in a safe condition.

In addition to its safety obligations, the town council has conservation objectives requiring it to retain trees with certain defects such as hollows and a certain amount of standing dead timber. Decaying timber on standing trees is of very high wildlife value. It is home to some of our rarest invertebrates who are entirely reliant upon it, as also are many kinds of fungi, lichens and mosses. It also provides a source of food to many specialist birds as well as nest and roost sites for birds and bats. However poor the condition of a tree, it is expected remedial work will only be necessary when there is a clear perceived risk to life or property which cannot be adequately reduced or eliminated by other means. The Health and Safety Executive (HSE) states that duty holders should not be encouraged to fell or prune trees unnecessarily.

The town council will be looking for future opportunities in time to plant more trees in the town.



# Potton Recycling

There have been a number of changes to the Potton Recycling scheme over recent months as a result of manufacturers withdrawing from sponsorship of some schemes. Please be aware that we can no longer accept coffee pouches, toothpaste tubes or packaging from crisps, nuts, pretzels and popcorn, although we do still take toothbrushes, electric toothbrush heads and packaging from biscuits, crackers and cakes. We also accept lots of other things including boxes from Ferrero chocolate, rubber gloves, plastic lunch boxes and water bottles and Pringles tubes. We've also recently started accepting packaging from bakery products, including Warburtons wax wrap, so please save your bread bags for us!

Changes can sometimes take place at quite short notice and we apologise for this, but we are subject to which



schemes Terracycle, the company which recycles the waste, is able to run at any given time. On a positive note, however, much of the soft plastic packaging which we can no longer accept in our local scheme can now be taken to most large supermarkets and deposited along with plastic bags in their dedicated recycling bins.

Please see the Potton Town Council Website at **pottontowncouncil**. **co.uk/recycling** for a complete list of everything we accept at any given time and always double check the bin labels before depositing your waste as they are always correct. The bins can be found opposite the public toilets on Brook End and all money raised goes to the Potton Hall for All. ### **Community Energy**

By way of an update, the Potton Town Council Community Energy Working Group is continuing as a town-council affiliated group. However, a Community Benefit Society has now been set up to cover the local region including Biggleswade, Potton and Sandy.

The group is called River Ivel Community Energy (RICE - https:// riverivelcommunityenergy.com). The group is a cooperative dedicated to helping local communities cut their heating bills and transition to renewable energy. RICE is a new group supported by Central Bedfordshire Council and Community Energy South. Although just set up last year, the group is making rapid progress, taking on-board training in the various powering up (sustainable energy generation) and powering down (improvements to housing insulation) such that we can now access advice from local Energy Champion volunteers.

For Potton, we are hoping to have Energy Champions visit the Friendship Group on a Thursday morning (date to be arranged) at the Community Centre in Brook End to present on the Powering down approach – which might help residents reduce their energy bills through using less gas or electricity! In addition to Potton residents, the Community Agent is keen to include residents from outlying villages and we will be contacting parish councils with details.

### **Community Safety**

The Community Safety Working Group continues to liaise with Bedfordshire Police and Central Bedfordshire Council's Safety Communities Officers on local criminal activities.

One problem identified is the reluctance of residents to report incidents. Several different routes for reporting incidents are listed below. This includes a fully confidential route independent of police - using Crimestoppers. If reported, police might investigate your specific incident (subject to resource), but they also register the incident on police records, which feeds into policing strategy and the potential for increased local policing. In addition, local series of crimes might have been stoppable had reports been made after the first incident. Note also that it is possible to report dangerous driving (make, colour and registration). Furthermore. local antisocial behaviour (ASB) could be reduced greatly if reported to police. Timely reporting can help to reduce this inexcusable expense to us all.

Finally, as a local dog walker, I have noticed a significant increase in deposits of dog mess around the town. **DOG OWNERS, PLEASE LIFT YOUR DOG'S MESS** – don't leave this mess on the streets for children to play in as well as for prams, buggies, wheelchairs and shoes to become contaminated for later distribution! The town council does provide dog waste bag dispensers in various locations in the town, with over 20,000 bags being used every year!

## **Brook End Car Park**

At the meeting of the town council in March 2025, the charging and enforcing of Brook End Car Park will be considered.



Potton Town Council (PTC) currently operates the free to use Brook End car park despite Central Bedfordshire Council charging the town council over £4,000 per year in rates.

Following a Town Benchmarking survey in 2017 the need for additional parking in the town to support our key services and shops was identified. Parking was seen as the largest single factor likely to deter people from using local shops and services. The town council therefore proposed the extension of the current car park given that space and land is at a premium in the centre of town. We hoped the extension, which was completed in 2019 and cost nearly £100,000, would alleviate parking issues and make it easier for people to access the shops and the local surgery.

The town council regularly receives complaints about the lack of parking and

the fact that many cars parked in the car park never move.

The town council carries out regular checks on vehicles parked in the car park, and will display notices for the following reasons:

- No Tax or MOT
- Parked in a disabled space without displaying a blue badge
- Not parking in a designated space
- Parking for a lengthy period which prevents maintenance of that space being carried out, e.g. cleaning drains, removal of leaves etc.
  (Town council staff will sometimes put cones on parking spaces at the end of the day so that maintenance can be carried out the next morning.)

## **Town Council Budget**

### The Town Council is funded through a small portion of the Council Tax known as a precept and by income it generates.

The town council does not receive any funding from central government, and following the Chancellor of the Exchequer's Autumn Budget to Parliament on Wednesday 30th October 2024, salary costs will increase.

The Ministry of Housing, Communities and Local Government (MHCLG) advised the town and parish sector in November 2024:

'I wanted to reach out following the Budget increase in Employer National Insurance contributions and what it means for parish and town councils. We are conscious that this will impact the finances of town and parish councils, and have been discussing the implications of these changes with colleagues at the Treasury. I'm writing to confirm that town and parish councils will not be included in a package to compensate public sector bodies for this rise.

The policy set by the Chancellor is to compensate those who are direct public sector employees funded out of public money. Parish councils are not directly funded by central government and so do not fall into this category.

We recognise that this will require town and parish councils to make some difficult financial decisions, and in particular that many may need to raise their precept, and that some may need to make staffing cuts in order to meet these new costs.'

On Tuesday 7th January 2025, Potton Town Council held a meeting of the full Town Council, where the 2025-26 budget and precept was set. It was voted to increase the council tax by 7.5%, to ensure a fiscally responsible budget. Potton Town Council increased Band D by £1.10 per month or £13.14 per year. We are committed to maintaining our existing services to support Potton residents.

> The total Council Tax bill in Potton will provide for Central Bedfordshire Council, Potton Town Council, Bedfordshire Police and Bedfordshire Fire and Rescue Service.

### **Update from Central Bedfordshire Councillor Adam Zerny**

### Government pushing hard for devolution - what will it mean for us?

The government has published a White Paper on 'Devolution' and wants local authorities to come together as groups, with a mayor. This could mean the loss of some local control but the government says in exchange these 'Strategic Authorities' will get extra powers on planning, transport and employment skills.

In England there are 317 councils; a mix of unitaries (e.g. Central Bedfordshire Council), counties (e.g. Cambridgeshire County Council), districts (e.g. South Cambridgeshire District Council), boroughs, metropolitan districts (e.g. Birmingham City Council) and London boroughs. They have different powers, sizes and funding; some areas have three or even four tiers (e.g. Cambridgeshire) whereas we have just two. The government is eager to reduce the number of tiers and says it wants a "shift of power away from Whitehall".

The government wants to bring groups of councils together as 'Strategic Authorities', each with a mayor who will get extra powers. It's important to note this is not about merging existing councils to create one really big council, but about giving specific powers to a mayor who would sit above a group of other councils. These powers might include:

- Co-ordination of buses, roads and rail policy across a region.
- Powers over sustainable energy, work skills and employment strategy.

- Involvement in health and policing (perhaps even doing away with Police & Crime Commissioners).
- More powers on planning decisions across a region and greater influence over new infrastructure.

The White Paper also mentions financial benefits which have accrued for other areas such as "£30.5 million of funding" achieved for Cambridgeshire and Peterborough, but of course none of this can be guaranteed for other areas.

These plans are not just about extra devolved powers though; the government clearly wants to reorganise how councils work, and I suspect it's also about easing the passage for major housebuilding.

I have met with the Leaders of the councils in Bedford, Luton, Milton Keynes, West Northants and North Northants, and we were in agreement that we need to understand more about what the government is proposing. Conversations will certainly continue with these local authorities, in light of this government report.

In a 35,000 word White Paper, the word 'referendum' gets not one mention. My understanding is instead of a public vote, there will be a consultation after which the government will make a decision.

While there is every indication the government wishes local authorities to come to arrangements about who they group with, the document says legislation "will allow the creation of those Strategic Authorities where local leaders have, after due time has been allowed, not been able to make progress."

I recently put forward a motion to all of the Central Bedfordshire councillors over whether they wished to investigate what devolution would mean for Central Bedfordshire residents, and this was passed unanimously.

I have since met with Local Government Minister Baroness Sharon Taylor to discuss further and there will be ongoing discussions in the months to come with the government and with our neighbouring local authorities.

My feeling is we need to learn more about what deal the government is prepared to offer and make a final decision only when we know what is on the table.

My primary concern is whether devolution will be for the good of the residents of our area.
